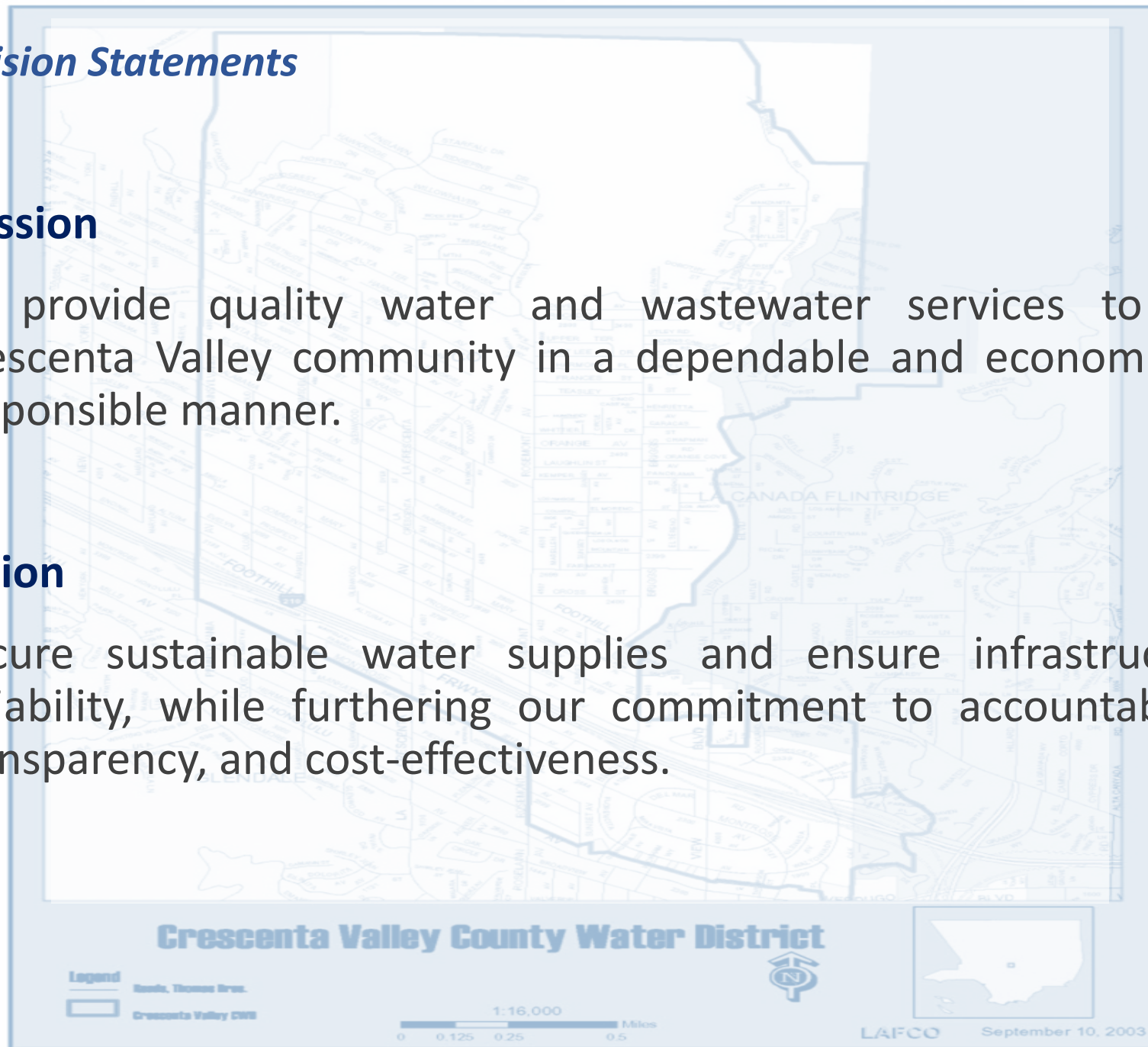

Vision

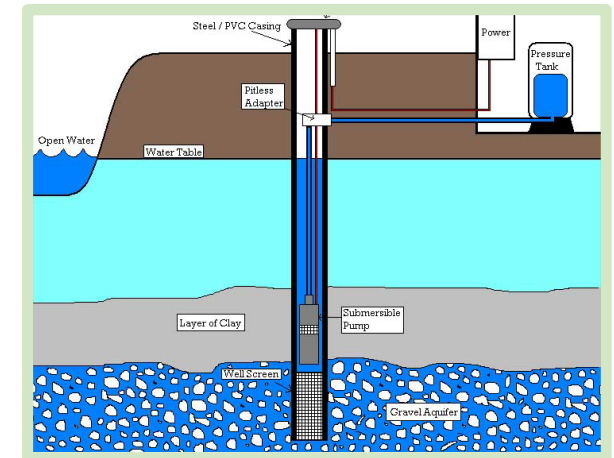
Secure sustainable water supplies and ensure infrastructure reliability, while furthering our commitment to accountability, transparency, and cost-effectiveness.

Background

- CVWD Board is committed to a long-term plan to address aging infrastructure and water supply reliability
- Significant portions of CVWD's infrastructure were built in the 1950s & 1960's
- Infrastructure is approaching or has exceeded its life expectancy
- Climate change and drought is impacting water supply reliability
- Operations and wastewater treatment costs are escalating with inflation
- A plan of action is needed to continue providing safe and reliable water and wastewater services to our customers today and into the future



Public Hearing for Proposed Increase in Water and Wastewater Rates and Charges

A Reliable Tomorrow Starts Today

- 2020 Strategic Plan
- Roadmap to Ensure Infrastructure Reliability and Financial Viability
- A Focus on Long-Term Infrastructure and Financial Planning
 - Developed Capital Improvement Plan to ensure reliability
 - Developed Funding Plan and Finance Options
 - Developed and Implemented Major Cost-Saving Initiatives (to mitigate potential rate increase)

Elimination of 7 full-time positions from 33 to 26 represents more than \$900K net savings every year going forward

Refinancing of debt represents \$63K savings annually for the next 15 years.

Reliability with Affordability

CVWD Gallons Per Capita Day

100 gallons per person per day¹



¹ Based on current population and water use, 1 person in a household is responsible for roughly 100 gallons per day, which includes not only consumption and personal hygiene but all other activities around the house requiring water.

Completing the Water Use Cycle

What Happens to my Wastewater?

- 71 miles of collection system pipelines
- 1.5 million gallons per day of wastewater
- Wastewater transported ~6 miles to City of Los Angeles' treatment plant (at 5 and 134 freeways)
- Portion of Wastewater transported ~27 miles to City of LA Hyperion treatment plant in Playa Del Rey

What Does it Cost to Treat Wastewater?

- Los Angeles charges the District to treat all wastewater
- \$1.9 million paid to Los Angeles for 2020/2021 fiscal year
- Treatment represents almost half of all CVWD's operating costs
- Los Angeles' fees have increased by over 60% over the last 2 years



A Reliable Tomorrow Starts Today

Approving the rate increase today ensures a more reliable future by making funding available for:

- Infrastructure replacements
- Water supply reliability projects
- Increase resiliency during emergency events – e.g., wildfires, earthquakes
- Asset management and preventative maintenance
- Increasing operating, maintenance, and energy costs
